2. INTRODUCTION

The Himachal Pradesh University, Shimla came into existence in July, 1970 through Himachal Pradesh University Act, 1970. Though it does encompass the challenges and limitation of hill University, it nevertheless stands apart from the rest in academic accomplishments. It has a beautiful campus spread over 200 acres. The University is surrounded by a panoramic view of nature having snow laden mountains, thick deep forests growing oak, pine and soul winning deodar trees. The University is one of the leading affiliating – cum- residential Universities in India, catering to the needs of more than 1.50 lac student. It enjoys the national and international repute. Besides departmental libraries, it has a six-storied library having a repository of more than two lakh books. 6. CREDIT BASED SEMESTER SYSTEM (CBSS)

The Himachal Pradesh University Institute of Legal Studies has designed the law course in the light of Bar Council of India guidelines. The purpose of such integrated course is to offer intensive and extensive Instructions of legal education so as to provide versatile human resource. The Institute is committed to prepare the students to perform better especially in the field of legal profession. All programmes of the course shall be run on Credit Based Semester System (CBSS).

It is an instructional package developed to suit the needs of the students to keep pace with the developments in Higher Education and the quality assurance expected of it in the light of liberalization and globalization in the Higher Education.

7. DURATION AND SCHEME OF THE COURSE

Duration of the course shall be five years. It shall have 60 papers spread over ten semesters. Each paper carries 100 marks, out of which 70 marks are assigned for End Semester Exam and the remaining 30 marks will be assessed on the basis of Continuous Internal Assessment. The components for Continuous Internal Assessment for Core/Elective Courses are:

Secretary to Government, Information and Tourism Department, (2009) 4 SCC 590.

9. NUMBER OF SEATS AND DISTRIBUTION THERE OF

10. PROCEDURE FOR SEEKING ADMISSION:

- Admission to the course shall be made strictly on academic merit, based on the marks obtained in 10+2.
- The list of the merit to this course shall be prepared by University Institute of Legal Studies, H.P.University, Ava-Lodge Campus, Chaura-Maidan, Shimla after conducting **Counselling on 16-06-2026** and **First Merit list shall be displayed** on the notice Board of the Himachal Pradesh University Institute of Legal Studies as well as on the website of HPU <https://hpuniv.ac.in> on **22-06-2026**.
- The Candidate shall be required to pay the fee and other charges as per fee structure of this Institute till the mentioned date (**Will be Notified Later**) failing which his/her right to **admission shall stand cancelled and the seat will be allotted to the candidate next in order of merit**.
Note: - For depositing the fee online it is compulsory that the name of depositor shall be that of the Candidate or the Parents/Guardian of the candidate. Once the fee has been deposited by the candidate in the www.nadmissions.hpshimla.in he/she shall immediately inform the institute telephonically. Thereafter the Institute, after confirmation from the Bank, will inform the candidate about his/her admission in the Institute.
- The fee once deposited shall only be refunded as per university rules.

11. INTAKE AND RESERVATION CRITERIA:

01	Out of total 120 seats 75 seats shall be the subsidised seats and the remaining 45 seats shall be the non-subsidised in accordance with the original format of the Institute as approved by HPU/BCI.
02	Reservation Criterion shall be applicable in respect of 75 subsidised seats as per provision contained under the First Ordinances of Himachal Pradesh University and instructions/notifications issued from time to time by the University in the following manner:
(a)	15% seats shall be reserved for candidates belonging to Scheduled Castes of Himachal Pradesh.
(b)	7.5% seats shall be reserved for candidates belonging to Scheduled Tribes of the State of Himachal Pradesh.
(c)	10% seats shall be reserved for Economically Weaker Section (EWS) candidates of Himachal Pradesh. However in case of non availability of EWS candidates the same shall be treated as Un-reserved (UR).
(d)	The remaining 67½% seats shall be filled as under:-
(i)	25% of seats shall be open to all the candidates irrespective of the institution from where they have passed their qualifying examination.
(ii)	75% of the seats shall be filled out of the candidates who have passed their qualifying examination from schools situated in Himachal Pradesh or who are Himachal Pradesh Domicile irrespective of passing qualifying examination from any other school established by law in India.
(a)	5% seats shall be reserved for person with disability with 40% to be certified by the competent authority.
(b)	Two seats for H.P bonafide candidate shall be reserved for Single Girl Child.
(c)	Two seats shall be reserved for wards of Kashmiri Migrants & Kashmiri Pandits/ Kashmiri Hindu Families (Non-Migrants).
03	Three seats shall be reserved under non subsidized category for University Wards as notified vide Notification no.5-1/88- HPU (Genl.)-Part-5 Dated 28th August, 2012.

- As per Judgement in CWP No. 1992/2017 and vide decision dated 12-01-2018 it has been decided by the Hon'ble High Court of Himachal Pradesh, Shimla that for academic sessions necessary instructions be imparted to the effect that vacant reserved seats meant for SC and ST categories in educational institutes including schools, colleges and Universities, which remain unfilled after exhausting the list of available and eligible SC and ST candidates, should be thereafter offered and filled from amongst eligible candidates from open category on the basis of merit. We clarify that in case any cut off limit has been fixed, then only those candidates of open category should be admitted against the vacant seats, who have gained marks at par with the cut off limit.

12. FEE STRUCTURE:

Fee Structure as Approved and notified Vide Notification no 1-10/2026-HPU (DS) Dated: 08.04.2026 is as under:

- I. Fee for Subsidized Seats = 70,580-00 (Per Annum)
 II. Fee for Non-subsidized Seats = 1, 10,280-00 (Per Annum)

- The student shall be required to deposit the fee and other charges in **two equal Installments** in **May & November** every year.
- The date(s) for the deposit of fee and other charges shall be notified by the Director from time to time. If a candidate fails to deposit fee in time his/her name shall be struck off from the roll of Institute. The candidate shall seek re-admission with a fine of **Rs.2500** /- within 15 days. After the expiry of 15 days without paying the re-admission fee he/ she shall be eligible to be admitted in next Academic Session in same semester.
- The Himachal Pradesh University Institute of Legal Studies, Shimla reserves the right to revise fee/other charges from time to time subject to the approval of the Himachal Pradesh University.
- Registration Fee:** The student shall have to fill the registration form and pay registration fee at the time of admission as per rates of the University rules as notified by the University from time to time.

13. CRITERIA FOR RESOLVING TIE:

The following formulae shall be adopted to resolve a tie for admission:

- In case of a tie, the candidate having higher aggregate marks in **matriculation examination** shall be admitted first.
- Further, if the tie is still not resolved the candidate **older** in age shall be admitted first.

18. DRESS CODE:

All students of B.A.LL.B. (Hons.) Five Years Integrated Course shall observe the following Dress Code on all working days:

For All : Black Trousers, White Shirt, Black Tie with Insignia, Black Coat of Single Breast /Black Buttoned up Coat with Insignia, Black Shoes, Black Socks and Tied Hair for Girls.

Dress code is mandatory for every student, failure of which invites the disciplinary action.

Optional for Girl Students: White Salwar Kameez, (without any print or design) with White duppatta and Covered Black Shoe.

19. ATTENDANCE REQUIREMENTS:

Each student will have to attend minimum 75% Lectures/Tutorials/Practicals. A student having less than 75% attendance will not be allowed to appear in the End-Semester Examination (ESE).

- a. Provided that the Director of the Institute may allow a student to appear in the examination on reasonable grounds, if such a student has attended at least 60% in the individual subject and 66% in aggregate of all the subjects. Such a student will apply for exemption in a prescribed form accompanied by clear reason(s) for absence to Director of the Institute.

20. PROMOTION RULES:

Ordinance 12.8 (A) to 12.12 (A); A candidate is required to pass in all the Courses of B.A.LL.B. (Hons.) in each Semester under the Credit Based Semester System provided that:

- (i) A candidate who appears in the examination and fails to obtain pass marks/Grade in any course in the First Semester, may be permitted to proceed to the Second Semester but shall not be permitted to proceed from the Second to the Third Semester without appearing in the examination and having qualified 50% of the total number of courses prescribed for First and Second Semester taken together.
- (ii) At the time of Third Semester examination the candidate may appear in the course in which he/she may have failed to obtain pass marks/Grade in the First Semester and also in all the courses prescribed for the Third Semester. But he shall not be permitted to proceed from the Third semester to the Fourth semester without appearing in the examination.
- (iii) At the time of Fourth Semester examination a candidate may appear in the courses in which he/she may have failed to obtain Pass Marks/Grade in the Second Semester and also in all the courses prescribed for the Fourth Semester but he shall not be permitted to proceed from the Fourth Semester to the Fifth Semester without appearing in the examination and having qualified 50% of the courses of first to fourth semester taken together.
- (iv) At the time of Fifth Semester examination a candidate may appear in the courses in which he/she may have failed to obtain Pass Marks/Grades in the Third Semester and also in all the courses prescribed for the Fifth Semester. But he/she shall not be permitted to proceed from the Fifth to the Sixth Semester without appearing in the examination.
- (v) At the time of Sixth Semester examination a candidate may appear in the courses in which he/she may have failed to obtain Pass Marks/Grades in the Fourth Semester and also in all the courses prescribed for the Sixth Semester. But he/she shall not be permitted to proceed from the Sixth to Seventh Semester without appearing in the examination and having qualified 50% of the courses prescribed for the First to Sixth Semester taken together.

- (vi) At the time of Seventh Semester examination a candidate may appear in the courses in which he/she may have failed to obtain pass marks/Grade in the Fifth Semester and also in all the courses prescribed for the Seventh Semester. But he shall not be permitted to proceed from the Seventh Semester to the Eighth Semester without appearing in the examination.
- (vii) At the time of Eighth Semester examination a candidate may appear in the courses in which he/she may have failed to obtain pass marks/Grade in the Sixth Semester and also in all the courses prescribed for the Eighth Semester. But he/she shall not be permitted to proceed from the Eighth Semester to Ninth Semester without appearing in the examination and having qualified 50% of the courses prescribed for the Seventh and Eighth Semesters taken together and all the Courses from First to Sixth Semester.
- (viii) At the time of the Ninth Semester examination a candidate may appear in the courses in which he/she may have failed to obtain pass marks/Grade in the Seventh Semester and also in all the courses prescribed for the Ninth Semester. But he/she shall not be permitted to proceed from the Ninth Semester to Tenth Semester without appearing in the examination.
- (ix) At the time of Tenth Semester examination a candidate may appear in the courses in which he/she may have failed to obtain pass marks in all courses of Seventh to Ninth and also in all the courses prescribed for the tenth Semester.

Note: - Subject to change by the H.P. University, Shimla-05 from time to time.

21. MIGRATION RULES:

1. That the migration rules framed under Chapter-III of H.P. University First Ordinances be applicable in letter and spirit.
2. That the applications will be invited from the interested students for migration at HPUILS at the end of the semester against vacant seats in each semesters during 1st February to 15th February for even semesters and 1st July to 15th July for odd semesters through Notice Board /on the Website of HPUILS.
3. That the migration of the students (those who applied during specified period) will be considered for the admission in each semester against vacant seats on the basis of academic merit in qualifying examination i.e. 10+2 or entrance score as the case may be rather than first come first serve basis.
4. That there will be no migration in first semester.
5. That no migration will be accepted in mid semester/session.
6. Any student willing to leave any institute (Affiliated to HPU, Shimla) can apply for migration by filling an application in the Institute where he/she is pursuing his /her studies.
7. Migration may be allowed only if there is vacancy in the Institute/College wherein the student is willing to join.
8. No Objection Certificate/Character Certificate from the Director /Principal of the parental Institute/College shall be mandatory for obtaining migration.
9. The migrated candidate shall deposit the fee applicable to non-subsidised seats only.

22. CONDUCT & DISCIPLINE RULES:

- (i) The student must observe and strictly follow the disciplinary rules and regulations of the Institute and abide by the provisions of Himachal Pradesh University Act, Statues Ordinances as framed and amended from time to time.
- (ii) Without prejudice to th generality of power to enforce discipline under the Himachali Pradesh University the following will amount to act of gross indiscipline.
 - (a) Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff and students of the institution,
 - (b) carrying or use of, or threat, of use of any weapon;
 - (c) any violation of the provisions of the Civil Rights Protection Act,1976;
 - (d) violation of the status, dignity and honour of students belonging to the Schedule Castes and Tribes;

- (e) any practice whether verbal or otherwise derogatory of women;
 - (f) any attempt at bribing or corruption in any manner;
 - (g) willful destruction of institution and property;
 - (h) creating ill-will or intolerance on religious or communal grounds;
 - (i) causing disruption in any manner of the academic functioning of the University system;
 - (j) ragging as per H.P University Statute 23-A.
- (iii) In the interest of maintaining discipline, the authority may order or direct.
- (a) that any student or students be expelled; or
 - (b) any student or students be, for a stated period, rusticated; or
 - (c) be not for a stated period, admitted to a course or courses of study in the institute; or
 - (d) be fined with a sum of rupees that may be specified; or
 - (e) be debarred from taking a University or institutional examination or examinations for one or more years; or
 - (f) that the result, of the student or students concerned in the Examination or Examinations in which he or they have appeared be cancelled.
 - (g) be placed on conduct probation.
- (iv) A student involved in the violation of any of the rules or regulations of the Institution or the University or in any way involved in any act of indiscipline may be placed on conduct probation by the Director of the Institution. A student placed on conduct probation shall not be allowed to represent the Institution or the University in any meet, tournament, youth festival or cultural competition during the period of his Conduct Probation. If a student, who has been on conduct probation on two previous occasions, commits an act of indiscipline, he shall be expelled from the Institute.
- (v) Rustication shall mean the loss of one academic year i.e. the student concerned shall not be allowed to appear in any University examination during the academic year in which he is rusticated. The actual period of expulsion from the institution shall depend upon the time of the year when the rustication order is passed. A rusticated student may, with the permission of the Head of the Institution concerned, rejoin his class in the same institution at the time of admission in the following academic year.
- (vi) A student, who is expelled from a institution, shall not be allowed to appear in any university examination during the academic year in which he is expelled and the next following year, and shall not thereafter be re-admitted to the same or any other institution without the prior sanction of the Vice-Chancellor.
- (vii) Each student shall be required to sign declaration that on admission he submits himself to the disciplinary jurisdiction of the university and the several authorities of the University who may be vested with the authority to exercise discipline under the Act, the statutes the regulations and the rules that have been or may be framed here under by the University .apart from this the student is also required to give an undertaking to present the ragging activities in the institute.
- (viii) Ragging (any kind of physical or mental torture) in and around the campus of the Institute or on roads/ approaches leading to Institute is strictly prohibited. If any student is found indulging in ragging directly or indirectly, will be dealt with as per provision of Statute 23-A of Himachal Pradesh University.
- (ix) Smoking and drug abuse is strictly prohibited within the Institute premises. The violators will be dealt strictly.
- (x) Punctuality and regularity in the class and assigned works should be followed. To appear in semester examination, all students must have minimum 75% attendance in all the courses.
- (xi) The name of student who either does not pay fee and other dues or remain absent without intimation/permission continuously for 7 days, his/her name will be struck off from the college rolls. Re-admission of such students will be done by paying re- admission fee of Rs 2500/- along with all other dues if any.

- (xii) The Institute believes in inculcating a sense of discipline, belongingness and commitment of the students by observing a dress code. No students will be allowed inside the Institute campus without proper dress code.
- (xiii) The Director shall have power under H.P. University First Ordinance, Vol. II, Chapter XLII, Ordinance 42.3 to impose a fine or other penalty in case he/she causes indiscipline in the Institute.

23. FORMATION OF STUDENT'S BAR COUNCIL (SBC):

The Composition of the Student Bar Council is as follows:-

- i) Patron-in-Chief - Director of the Institute.
- ii) Two teachers and one Non-teaching employee shall be nominated by the Director of the Institute.
- iii) Two members each from all the year such as 1st, 2nd, 3rd, 4th and 5th Year on the basis of their academic /extra –curricular activities.
- iv) The Patron-In-Chief shall nominate the following members of Student Bar Council as President, Vice President, General Secretary and Joint Secretary:

President	Student of 5 th Year
Vice President	Student of 4 th Year
General Secretary	Student of any Year
Secretary	Student of any Year

- v) Student Bar Council shall assist and help the authorities to redress the grievances of the students or submit any suggestions for the betterment of the Institute and to organize extra –curricular activities such as Moot Court-Competitions, Educational Tours, Sports and Cultural functions etc. Student Bar Council shall be constituted every year during the month of September-October.
